### **Welcome and Introductions**

Lenz called the meeting to order at approximately 4:05 p.m. and introductions were made.

Lenz reviewed the RFP and resolution which created the Poet Laureate program and the process of selecting an applicant. The City received two applications which the subcommittee reviewed and unanimously selected Mai Kao Hang as their recommendation with Barry Liss being recommended as the alternate.

Montgomery made a motion to recommend Mai Kao Hang as the Poet Laureate to the Economic Development committee. Fleming seconded. Motion carried unanimously, 5-0.

### **Discussion and possible action on approving new sculpture in RiverLife**

Lenz reviewed the sculpture proposal. The sculpture will be paid for by the Walter Alexander Foundation and they are requesting that the City maintain the sculpture, relocate landscaping from the site and run electricity to the site. Lenz clarified that cleaning of the bronze sculpture would be one of the maintenance items required. Currently the Parks Department cleans the bronze sculptures in Wausau but may consider an outside vendor if the number of sculptures continue to increase.

The commission noted that they hoped that there will be a more realistic look to the water and logs as well as suggested the human figure is historically accurate. Staff will pass along the commission's comments to the foundation.

Fleming made a motion to approve sculpture. Montgomery seconded. Motion carried unanimously, 5-0.

Nick explained that Terrance Wall met the artist at an art fair and liked the sculpture, so he commissioned some pieces to be used at his properties. Nick commented that for Foundry phase 2, he would be open to sourcing local artists if that was of interest to the Commission. Due to a lack of quorum, no motions or discussion occurred and the item will be placed on the next agenda for action.

Dear Commissioners and Committee Members:

I am writing to request approval to install a heart sculpture within the public right-of-way at the location identified in the attached exhibits.

The proposed sculpture is intended to serve as a welcoming public art feature that enhances the character of the Foundry on 3<sup>rd</sup> development and contributes to the vibrancy of the surrounding downtown area. The location has been selected to complement pedestrian activity while maintaining safe and appropriate use of the right-of-way. The sculpture will sit on a base measuring 15 inches wide by 60 inches long.

For your review, we have included the following exhibits:

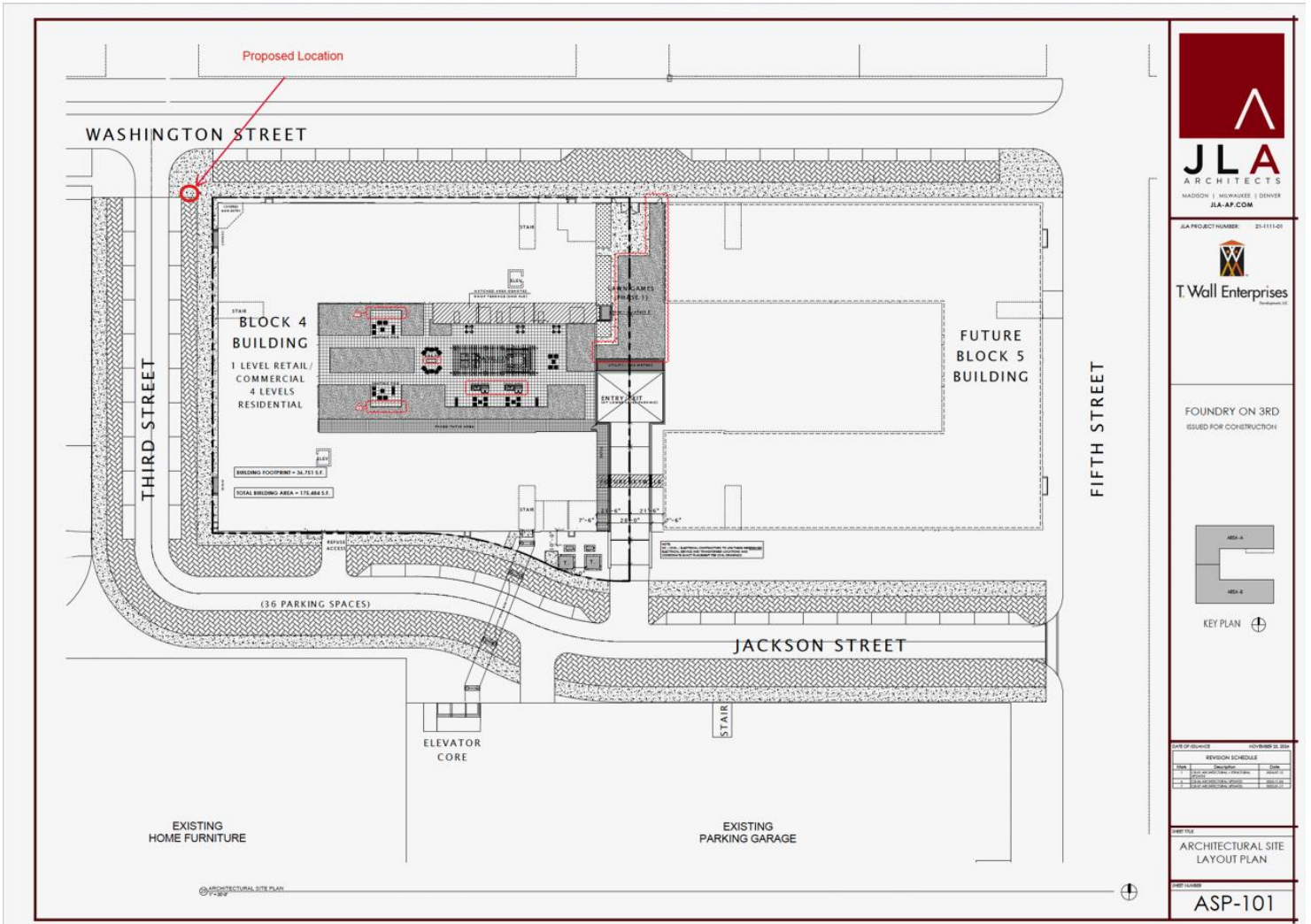

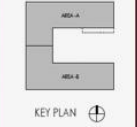

## 2.60.280 Wausau Arts Commission.

- (a) *Purpose.* The arts are an intrinsic expression of human life. Thriving communities enjoy shared experiences of diverse and abundant arts and culture. Arts investments create jobs, leverage private gifts, build a sense of place, invite tourism, revitalize neighborhoods, attract creative people, cultivate democracy, preserve cultural legacy, generate local tax revenue, and enhance our quality of life. The Wausau Arts Commission exists to advise the Wausau City Council on the planning, programming, procurement, installation, operations and maintenance of public visual art projects and artworks.
- (b) *Definition.* "Commission" means the Wausau Arts Commission.
- (c) *Structure.* The commission shall be staffed by the Department of Planning and Community and Economic Development and shall assist and work with the Economic Development Committee, as well as the committees of the Common Council, as needed.
- (d) *Composition.*
  - (1) *Commission membership.* The commission shall consist of seven members, including one Alderperson. The remaining members shall be citizen members who are Wausau residents and are actively involved as a member of Wausau's art community. Members shall be appointed by the Mayor and confirmed by the Council.
  - (2) *Terms.* The terms of all commission members shall be for three years or until their successors are qualified. However, the term of the Aldermanic member shall expire with the expiration of her/his term as Alderperson, and the members appointed to the first term following the effective date of this ordinance shall be appointed to staggered terms. Two members shall serve an initial term of one year, two shall serve an initial term of two years, and two shall serve an initial term of the full three years. No member shall serve more than two consecutive three-year terms. However, the members appointed to the first term after the effective date of this ordinance who serve an initial term of less than three years, and any member appointed to fill the unexpired term of a former member, shall be eligible to serve two full consecutive three-year terms thereafter.
- (e) *Commission authority.* The commission shall have the following powers and duties in advising the Mayor and the Common Council:
  - (1) Establish and administer guidelines and procedures for securing and distributing grants, and securing private funding for art purchases;
  - (2) Implement the City's art program, including but not limited to a review and selection process for purchasing, commissioning, and siting works of art;
  - (3) Advise municipal efforts to engage artists and creative workers and the community in a broad range of civic initiatives;
  - (4) Coordinate and support efforts to unite and focus municipal programs and services as they relate to the arts and cultural activities.
