Approve minutes of the September 2, 2025 meeting

Jacobson moved to approve the minutes of the previous meeting. Groat seconded and the motion passed.

Open bids and make recommendation for 2025 Sidewalk Repair Project “B”

One bid was received, which was from Pember Companies, Inc. in the amount of \$85,976.95. The bid will be reviewed and brought back with a recommendation.

2025 Asphalt Patching Project: RC Pavers, LLC, Pay Estimate #3

This pay estimate was reviewed by the project inspector and approval is recommended. Lindman moved to approve Pay Estimate #3 in the amount of \$17,226.48. Groat seconded and the motion passed unanimously.

2025 Street Construction Project “B” – Fulton Street/1st Street/2nd Street: Switlick & Sons, Inc., Pay Estimate #5

This pay estimate was reviewed by the project inspector and approval is recommended. Lindman moved to approve Pay Estimate #5 in the amount of \$299,221.60. Groat seconded and the motion passed unanimously.

Wausau Wastewater Treatment Facility Screening Improvements: J.F. Ahern Co., Pay Estimate #5

This pay estimate was reviewed and approved by the contract inspector. Lindman moved to approve Pay Estimate #5 in the amount of \$401,993.45. Jacobson seconded and the motion passed unanimously.

Portland Cement Concrete License: Rob’s Construction LLC and ABG Masonry, Inc.

Jacobson reviewed both licenses and moved to approve both. Lindman seconded and the motion passed unanimously.
